RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT in consideration of and exchange for Rope Skipping Alberta allowing my participation in its activities and programs, I agree to:

1. Give up any and all claims that I have now or might have in the future against Rope Skipping Alberta. I also agree to release them from any responsibility for any loss, damage, or injury, including death, that I or my family might suffer because of my participation in these activities.
2. Give up claims for losses that happen for any reason, including mistakes, failure to fulfill commitments, or failure to take proper care by Rope Skipping Alberta.
3. Give up claims for losses that happen because Rope Skipping Alberta didn't take reasonable steps to keep me safe or protect me from the risks and dangers of their activities.

MEMBER RESPONSIBILITIES I agree to follow the rules of Rope Skipping Alberta. While participating in their activities, I will wear safe clothing and proper footwear for rope skipping, avoid wearing jewelry, and not chew gum. If I participate in Rope Skipping Alberta activities outside of regular practice spaces or without a certified coach, I understand that it is completely my choice and at my own risk. I accept all the risks and dangers of doing rope skipping at home or any other place outside my usual practice area, and I fully understand that participating without a certified coach or first-aid provider is risky.

MEDIA RELEASE I agree to let Rope Skipping Alberta use photos, videos, and audio recordings taken of me at any skipping event. These can be used for promotional purposes, websites, newspaper articles, press releases, live streaming, video replay, or AI speed and power judging, forever.
